Filing Requirements

Candidates for the above elections must file this fully executed official Filing Form with the appropriate fee(s) by U.S. mail to the New Kent County Republican Committee, P.O. Box 831, Quinton VA 23141 or by hand delivery NO LATER THAN 5:00 PM ON Wednesday, MARCH 11th, 2026, 5:00 PM. Alternately, the arrangements committee, Pat Bell or Virginia Kelm, will be available for application drop off at the Old School Cider house, 9302 Eastview Lane, Providence Forge, VA 23140 on March 11, 2026, at from 3:00 PM to 5:00 PM, local time. Call or text 804-937-5820, upon arrival.

FAX OR EMAIL SUBMISSIONS WILL NOT BE ACCEPTED. Illegible, incomplete, or invalid filings, and any altered or changed reproductions of the Official Filing Form, will be subject to rejection, and accompanying fees will be deemed contributions to NKCRC. Each application must be accompanied by a separate check or money order from the applicant for the Total Fees calculated above. Each filing form shall have a separate personal check or money order for any applicable filing fees attached to such form. The only exception, payment may be combined for up to 2 filing forms of members from the same household. Otherwise, Grouping of Filing Forms with one payment will not be accepted
